In a head of tide dam removal on the Kickemuit River in RI, there was less sediment movement than predicted in the engineers modeling. The two dams at head of tide had impounded water on a former salt marsh for over 100years causing marsh subsidence that resulted in elevations too for marsh recolonization in the flood plain post dam removal.

Couple macro options: 1) manage the sediment by removing and disposing or stabilizing in place (capping) and then remove the dam; 2) maintain the dam / head pond elevation to prevent sediment migration and promote fish passage with fish ladders, rock ramp fishways, nature-like bypass channels, etc.
